Adding new concepts such as The Real Greek is in-line with our strategy to broaden the range of cuisines on offer to our guests, especially in The Plaza, our fast-casual dining hub."

This news follows the recent signing of Big Easy at Bluewater, for its first location outside of London, and Landsec's positive half-year results announcement, which point to the increasing importance of dining and leisure in creating a compelling, all-day offer for a destination.
