## Landsec and Taylor Wessing sign agreement for refurbishment of London Headquarters

Landsec and Taylor Wessing have agreed a renewed lease for 175,000 sq ft of space at 5 New Street Square, EC4 from 2025. The global law firm is investing in the future of its office, partnering with Landsec to carry out an extensive refurbishment of the building.

An exciting vision has been created for 5 New Street Square as a reimagined, modernised and more sustainable London headquarters.

The refurbishment will deliver the look, feel and facilities of a new building, with less environmental impact than would result from building and fitting out a brand new premises. Sustainability considerations were front and centre in Taylor Wessing's decision to remain in 5 New Street Square.

One of the main elements of the work to be led by Landsec include decarbonisation of the building through replacement of gas boilers with air-source heat pumps to set it on a pathway to net zero carbon. The plans also include new designs for reception, lifts and outdoor spaces, including a new communal terrace. Sustainability is at the centre of all decisions in the refurbishment process, with the collective objective to retain and repair where possible, rather than replace.

The new space will target a minimum of BREEAM Excellent and WELL Gold Core. As part of the refurbishment, Landsec and Taylor Wessing are targeting best practice levels of energy efficiency and commit to monitoring and reporting on energy consumption throughout operation.

Taylor Wessing's Real Estate team led on the negotiation of the Agreement for Lease and reversionary lease terms.

Oliver Knight, Head of Workplace at Landsec said: "Workspaces play a vital role in bringing people together to develop long term trusted relationships, promote wellbeing and foster company culture. Alongside this, sustainable office space plays a pivotal role in helping businesses meet their ESG targets, which is increasingly driving decision making. Businesses are looking for spaces that can support their people whilst also reflecting their values, having a space that is environmentally friendly sits at the heart of this.

"Our partnership approach combined with the scale and quality of our portfolio means we're able to offer solutions for businesses no matter what stage they're at in their journey. Working alongside Taylor
